AFFIDAVIT FOR UNCONTESTED FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

1. That I am the Petitioner/Respondent in this matter.
2. That I have been a resident of the State of Florida more than six (6) months prior to the filing of this action as corroborated by a legible copy of my Florida Driver's License which has previously been filed in this matter.
3. The marriage between me and the Petitioner/Respondent, _____, is irretrievably broken and no intervention or assistance by the Court will be able to keep the marriage intact.
4. **(Alternate 1)** There are no minor children of the marriage and I am not currently pregnant.

(Alternate 2) There are no minor children of the marriage and to the best of my knowledge my Wife is not currently pregnant.
